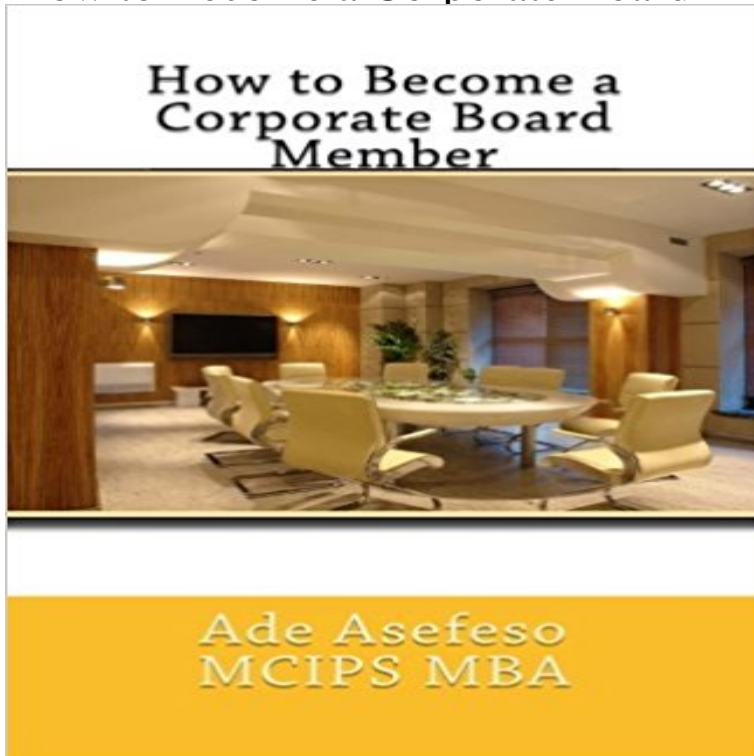


## How to Become a Corporate Board Member
